DIRECTIONS TO THE SHINGLE SPRINGS RANCHERIA

From Lake Tahoe:

1. Take Hwy 50 West
2. Take Exit 40 Red Hawk Parkway
3. Take a right at the intersection
4. Take immediate right onto Honpie Road
5. Stop at the guard shack on the right for further directions

From Sacramento:

1. Take Hwy 50 East
2. Take Exit 40 Red Hawk Parkway
3. Take a right at the intersection
4. Take immediate right onto Honpie Road
5. Stop at the guard shack on the right for further directions

VENDOR INSTRUCTIONS

1. All vendors require a Vendor Permit issued by the Shingle Springs Band of Miwok Indians to operate a booth on the Shingle Springs Rancheria. Fill out this application in its entirety and send to the address highlighted in bold the first page
2. Applications will be reviewed and a decision made within fourteen (14) days. You will be notified by mail, telephone, email or in person of the decision.
3. After you have been notified that your application has been approved you may pay your vendor fee which is \$40.00 in advance, \$60.00 the day of the event.
4. When you come to the Rancheria on the day of the event, stop at the guard shack to pick up your **VENDOR PERMIT AND VENDOR'S PARKING PASS.**
5. Booths will be assigned on the day of the event, if room is still available.

RULES

1. The Shingle Springs Band of Miwok Indians reserves the right to cause for the removal of any individual from the Shingle Springs Rancheria or areas within without prior notice, at any time for any reason.
2. The sale of alcohol, drugs, pornography and/or firearms by any individual is strictly prohibited and will result in immediate removal from the premises.

3. The Shingle Springs Band of Miwok Indians 23rd Annual Big Time is a Drug, Tobacco and Alcohol-free event. (Tobacco products will only be allowed for ceremonial purposes)
4. No store bought crafts will be allowed to be sold.
