# PUBLIC GUIDE INFORMATION SHEET TOPIC: Guardianship - Attachment to petition

### How to Fill Out an Attachment to the Guardianship Petition FL-403

Please read these instructions before filling out the form. If you have questions, please contact the Clerk of the Court. While Court staff cannot provide you with legal advice, staff may be able to provide you with referrals and resources to those who can assist you.

#### Who Should Fill Out this Form?

This form must be attached to the Petition for Guardianship (form FL-400) when the person filling out the Petition for Guardianship is **not** the proposed guardian (the person looking to become the guardian for the child/ren). Only the **proposed guardian** needs to fill out this form. If you are not the proposed guardian, do not fill out this form. If more than one proposed guardian needs to fill out this form, each person will need to fill out a separate FL-403 form.

#### **Proposed Guardian Information**

Name of Proposed Guardian: Please write your full name.

Address: Please write the street address, city and zip code of your place of residence.

<u>Mailing Address</u>: If your mailing address is different from the address listed above, please write the address, city, and zip code of your mailing address (PO Box can be added here).

Phone: Please provide the phone number you can most easily be reached on.

Date of Birth: Please write your full birthday (month, day, year)

#### **Question 1.e.**

Check **one** of the boxes listed. If none of the boxes apply to you, please check "Other interested person" and describe your relationship to the child (how you know the child, how long you have known the child, etc.)

#### Question 1.f.

Check yes if you are a Shingle Springs Band of Miwok Indians Tribal Member, check no if you are not.

#### Question 1.g.

If you do not have any criminal convictions, check the first box. If you have been convicted of a crime, check the second box and list the crime(s) you were convicted of. List all juvenile, state or federal court convictions.



**Note**: being arrested for something is not the same as being convicted of a crime. If you have been arrested, but not convicted of a crime, you do not have to list it or count it as a criminal conviction for this section.

#### **Question 2**

You will need to check boxes (a) through (c) to be eligible to become the child's guardian. By checking these boxes, you agree to comply with the home and criminal background checks that the court requires proposed guardians to complete. You also agree to cooperate and assist with other reports that must be completed.
