#### Please Note

Returning to traditional Big Time values and practices, we only approve applications from vendors selling genuine Native-made items. Vendors are expected to adhere to the Indian Arts and Crafts Act (Act) of 1990 (P.L.101-644), which is a truth-in-advertising law, prohibiting misrepresentation of marketing Indian art and craft products within the United States. It is illegal to offer or display for sale any art or craft product in a manner that falsely suggests it is Indian produced, an Indian product, or the product of a particular Indian or Indian tribe or Indian arts and crafts organization, within the United States. No manufactured or imported overseas goods allowed. The Shingle Springs Band of Miwok Indians reserves the right to remove any individual from the Shingle Springs Rancheria without prior notice, at any time, for any reason. The sale of alcohol, drugs, obscene materials and/or firearms is strictly prohibited and will result in immediate removal from the premises. This is a drug, tobacco and alcohol free event. Tobacco products will only be allowed for ceremonial purposes.

Vendor spaces are 10X10 and are \$100.00 in advance or \$150.00 the day of the event. If you require additional space you will need to purchase the additional space. This is a two day event and vendor fees are the same, even if you only attend one day.

## **Big Time Vendor Instructions**

(Keep this for your records)

- All vendors must be issued a Vendor Permit by the Shingle Springs Band of Miwok Indians (Tribe) to operate a booth at Big Time
- Decisions on vendor applications are made within fourteen (14) days. You will be notified by mail, telephone, email or in person. The Tribe reserves the final right of vendor approval.
- Once you are notified your application is approved, you must pay the vendor fee. Do not submit payment prior to your application being approved. Acceptable forms of payments are cash, check, or money order. You can pay in person, at the Shingle Springs Rancheria (first floor Tribal Admin) or by mail

- Vendor spaces are assigned as applications are received and electricity/water is no longer available
- Each vendor is required to donate a \$25 value raffle item
- Food vendors will no longer be assigned to the Big Time grassy area. Food will be located across from Big Time, in the Tribal Admin parking lot. You must wear gloves when handling or preparing food.
- No RV hookups
- All vehicles must be parked in the designated vendor parking lot, except for loading and unloading. There is a strict no parking policy around Big Time area.
