## PUBLIC GUIDE INFORMATION SHEET

### TOPIC: Property Control – Attachment to Petition for Protection Order

#### **How to Fill Out an Attachment to Petition for Protection Order: Property Control, Form**

**DV-101E** Please read these instructions before filling out the form. If you have questions, please contact the Clerk of the Court or your Wadaapé Advocate. While Court staff cannot provide you with legal advice, staff may be able to provide you with referrals and resources to those who can assist you.

**NOTE TO PETITIONER/PERSON TO BE PROTECTED: You must complete form DV-101E and attach it to the Petition for Protection Order if you checked box 2(e) on the Petition for Temporary or Permanent Protection Order form DV-101.**

You are filling out this form to ask the Court to give the Person to Be Protected the temporary use, possession, and control of property as requested in Form DV-101E.

**Case Name & No.:** Write the name of the Person to be Protected in the Case Name box. Leave the Case No. blank.

**Box 1: Home Location** Check this box if you want a home residence to be under the control of the Person to Be Protected and not under the control of the Respondent. Please provide the physical address in this section.

**Box 2: Vehicle** Check this box if you want a vehicle to be under the control of the Person to Be Protected and not under the control of the Respondent. Please provide the details of the vehicle including make, model, year, color and mileage. If you wish to have control over more than one vehicle, please attach a sheet of paper and list each vehicle.

**Box 3: Bank Accounts** Check this box if you want any bank account(s) to be under the control of the Person to Be Protected and not under the control of the Respondent. Please write in the details of the bank accounts, with one entry per account as follows: bank name and type of account. If there are more than three bank accounts to list, attach a separate sheet with the bank name and type of account.

**Box 4: Mobile Phones & Wireless Accounts** Check this box if you want any mobile/cellular devices under the control of the Person to Be Protected. Include the wireless accounts associated with the mobile phone being requested. Check all boxes that apply. Please include the make/model of the phone and the phone number. You may request more than one phone, wireless account and phone number in this section if there are any children in the care of the Person to Be Protected who also need to be included.

**Box 5: “I ask the court order Respondent to make payments...”** Check this box if you want to request that the Court orders the Respondent to make payments for the wireless phone

**Box 6: Tribal Stipends for Minors** Check this box if there are children in the care & custody of the Person to Be Protected - and the Respondent should NOT have access to the Tribal Stipends for these children. Please list each child's full name and age.

If the Person to be Protected wants FULL temporary control over the children's Tribal Stipends and does not want the Respondent to have any control, please give a reason why Respondent should not have any control.

**Box 7: Tribal Per Capita Payments** Check this box if you're requesting that the Court protect your Per Capita payments from the Respondent to do the following: attempt to take, cash, borrow against, spend, encumber or other use any Tribal Per Capita payments distributed in the name of the Person to Be Protected.

**Box 8: Social Media Accounts** Check this box if you want the Court to order protection of any social media accounts under the registration and name of the Person to Be Protected. If you check this box, the Respondent may not use, log onto, change passwords or use credentials or pretend to be the Person to Be Protected on social media to gain control of their social media accounts.

**Box 9: Other Property** Check this box if you have other property not specifically covered by the other sections in this form. Please list, describe, and give reason for the request to protect other property.

**Signature** Do not forget to sign and date the form at the bottom and attach to your Petition for Protection Order.
