## **PUBLIC GUIDE INFORMATION SHEET TOPIC: Dividing Assets – Attachment to Petition for Protection Order**

### How to Fill Out an Attachment to Petition for Protection Order: Dividing Assets, Form

**DV-101F** Please read these instructions before filling out the form. If you have questions, please contact the Clerk of the Court or your Wadaapé Advocate. While Court staff cannot provide you with legal advice, staff may be able to provide you with referrals and resources to those who can assist you.

# NOTE TO PETITIONER/PERSON TO BE PROTECTED: You are asked to complete form DV-101F and attach it to the Petition for Protection Order if you checked box 2(f) on the Petition for Temporary or Permanent Protection Order form DV-101.

You are filling out this form to ask the Court to divide up assets held between the Person to Be Protected and the Respondent for the duration of the Protection Order.

#### **Box 1: Real Property**

Check this box if you want the court to divide real property interests between the Person to Be Protected and the Respondent as a part of the Protection Order. Check each type of real property. The types are a home or developed land or undeveloped land. You will also need to check the box that shows who you wish to use that property during the time the Protection Order is in place. You can check the box for either the Person to be Protected or the Respondent. You can list up to 3 types of property on the form but if you need more space, please attach a separate sheet and list out the remaining property.

#### **Box 2: Vehicles**

Check this box if you want any vehicle(s) to be divided between the Person to Be Protected or the Respondent. Please write in the details of the vehicle requested as follows: make, model and year. Be sure to check the appropriate box as to which Party should receive each vehicle.

#### **Box 3: Bank Accounts**

Check this box if you want any bank account(s) to be divided between the Person to Be Protected and the Respondent either in whole or in part. Please write in the details of the bank accounts, with one entry per account as follows: bank name and type of account. Specify the percentage (%) of division between the parties for each account that you would like to see.

## Box 4: Personal Effects & Other Property

Check this box if you want any personal property divided which <u>does NOT include real property</u> (house or land) or vehicles; personal property may refer to items such as furniture, household items, collections, tools, jewelry, regalia, clothing, appliances, artwork, etc. Check the appropriate boxes and list the property – if you need more space, please attach separate sheets.
