In order to return to traditional Big Time values and practices, we will only accept applications from vendors selling genuine Native-made items. All vendors are expected to strictly adhere to the Indian Arts and Crafts Act (Act) of 1990 (P.L. 101-644), which is a truth-in-advertising law that prohibits misrepresentation in the marketing of Indian art and craft products within the United States. It is illegal to offer or display for sale, or sell any art or craft product in a manner that falsely suggests it is Indian produced, an Indian product, or the product of a particular Indian or Indian tribe or Indian arts and crafts organization, resident within the United States. No manufactured or imported overseas goods will be allowed.

Spaces are 10x10 and cost \$100.00 in advance or \$150.00 the day of the event. If your space requirements are more than 10x10, you will need to purchase additional space. This is a two-day event and the vendor fee remains the same even if you plan to set up only for one day.

BIG TIME VENDOR INSTRUCTIONS

- All vendors require a Vendor Permit issued by the Shingle Springs Band of Miwok Indians (Tribe) to operate a booth at Big Time
- Spaces will be assigned as applications are received
- Decisions on applications will be made within fourteen (14) days. You will be notified by mail, telephone, email or in person. The Tribe reserves the right to final vendor approval.
- After you are notified that your application is approved, you may pay your vendor fee. We accept cash, checks or money orders. You may pay in person on the first floor of the Tribal Administration Building or you can mail your payment to the address below.
